### Bright Idea – Solar Panels

Although we've only had them for about three months now, our solar array earns a handsome return every day, and if you can answer yes to a few simple questions, you can get your roof working for you, too.

When planning the renovation of our home on Greenspring Avenue, we knew we wanted to make our house as energy efficient as possible. After ensuring that we had a tightly sealed and well-insulated building, we turned our attention to the heating and cooling systems. We learned that combined with standard, high efficiency electric heat pumps and gas backup water heating, installing solar electric and solar hot water was the way to go. This option made more sense for our relatively easy to heat and cool 2800square-foot home than installing geothermal heating and cooling. For larger, more difficult to heat and cool homes -- particularly ones not well suited to solar – geothermal is often an excellent choice, but it was not for us.

So what makes a house well suited to solar? Most importantly, you need a clear and open south or southwest-facing roof. Second, that roof either needs to be in very good condition or due to be reshingled. It is not sensible to install solar panels on a roof that may need replacement soon. Slate roofs may add a layer of complexity to the process, but are not a deal-breaker in most cases. Third, you must have the desire to earn an excellent return on your investment that will make you feel great every day the sun shines. While the economics of each project will vary, ours made excellent sense. In very rough terms, our 470 square foot, six kilowatt array cost about \$20,000 after generous tax credits and rebates, and will produce about 8,000 kWh of electricity per year, worth around \$800 a year at 10 cents a kWh. That's a 4% return on investment for producing a good portion

of your home's power in a sustainable manner. What CD or Money Market can do that?

But here's where things get interesting, and a bit complicated. Modern solar systems are "net metered." If your system generates more than you are using at any given moment, the extra power goes "back up the line," your meter runs backward and you earn a credit on your bill. If at any moment you are drawing more energy than you are generating, your meter runs forward. Your meter tallies the pluses and minuses, you always have all the power you need, and you get a regular BGE bill once a month charging you for your net usage - or literally sending you a check if you generate more than you use.

But there's more. When you register your solar electric array with the proper authorities, it actually becomes a small

electric generating facility and gets counted toward the renewable generating capacity of Maryland's electric grid. By statute, at least 2% of the total energy production in the state of Maryland must come from solar power by 2022. Building commercial solar capacity is extremely expensive and many regional electric companies would be only too happy to pay YOU to count your array toward their renewable requirements. This is accomplished through a market for what are known as Solar Renewable Energy Credits (SRECs). Most of the major solar installers should take care of the paperwork required to register your system and market your SRECs. At current market prices, our system will generate well over \$2,000 worth of SRECs per year – more than the retail value of the electricity it generates! Counting the value of the electricity and the SRECs, our system will throw off about \$3,000 of annual income on a \$20,000 investment – or a 15% rate of return. And that's at the current price of electricity, which is only going up. I ask what other investment allows you look up at your roof and smile proudly – AND earns money?

## The Mount Washington School Receives National Honor

The Mount Washington School capped off an historic year of achievements in September with the receipt of the highest honor in American education: Mount Washington was named a 2012 National Blue Ribbon School by the U.S. Department of Education.

The school was one of 305 across the nation to receive the honor, one of only six in the State of Maryland, and only the seventh Baltimore City school to receive the national distinction since its inception in 1982.

"When the Baltimore City Board of Commissioners approved the school's expansion to include middle grades this year, it was a strong statement by the district about the kind of excellence we are striving to create for all of our students," said City Schools CEO Dr. Andres Alonso. "To have this national honor on top of that is strong affirmation that we can and will get there. I extend sincere congratulations to Principal [Sue] Torr and Mount Washington's families and staff."

The winners will be invited to Washington D.C., November 14-15 and will be honored by national officials including U.S. Secretary of Education Arne Duncan. "This award is a reflection first and foremost of the hard work of Mount Washington's students, followed by our talented, dedicated teachers and our supportive, involved parents and community," Ms. Torr said. "This prestigious award is an honor and a thrill."

The award followed a series of accomplishments, including:

• Last fall's selection by the Maryland State Department of Education of MWES as a 2010-2011 Maryland Blue Ribbon School of Excellence. This award, given to only six schools in the state, honored Mount Washington for



its students' academic improvement, the tremendous volunteerism of its parents, its championship basketball team and its one-of-a-kind partnership with the Johns Hopkins University Center for Talented Youth (CTY) online math program.

- A CNN feature highlighting the MWES-CTY partnership, which aired in March
- The designation in 2010 of MWES as a Maryland Green School.
- The basketball team's second consecutive citywide basketball championship.
- The chess team's victory in a statewide tournament.
- And the naming of 5th grade teacher Jennifer May as Baltimore's Teacher of the Year.

In August, more than 500 community members and City leaders, including Dr. Alonso and Mayor Stephanie Rawlings-Blake, gathered to celebrate the launch of the long-awaited expansion of Mount Washington to a K-8 school. The 18-month project culminated with the addition this year of the school's first ever sixth grade class and the implementation of the highly respected International Baccalaureate Program. Grades seven and eight will be added over the next two years.

### **Traffic Update**

The Traffic, Transportation and Infrastructure committee of MWIA has been working with the Baltimore City DOT since last spring to evaluate and address speed, signalling and traffic issues that involve Smith Avenue, Mt. Washington Village and the traffic patterns along Greely to Kelly and Sulgrave. This is an ongoing concern, now even more crucial since the opening of the Mount Washington Lower School.

In November 2011, DOT will install a pad for a rotating speed camera on Smith on the the southeast side near Thornbury. A camera will appear thereafter, similar to the one that cycles in and out on Kelly Avenue. There will also be a "School zone/ 25mph/ Photo Enforced" combination sign installed nearby.

In addition, DOT has begun to prepare the hardware for a left turn sign for westbound Smith Avenue traffic turning to Greely. The department plans to activate that signal as soon as pavement markings have been installed; tentatively expected in November.

One of the the traffic committee's goals is to facilitate communication between DOT, area residents, the Mt. Washington Merchants Association, and MW School about this issue. As these organizations work together to review efficacy of the speed cameras, signage, signal changes and other remedies, Mt. Washington should see improved pedestrian safety and vehicle traffic flow in this busy area.

# The Eric Waller Mount Washington Community Vegetable Garden

Mount Washington's community vegetable garden has enjoyed an unbelievably successful first year. The members have been harvesting crops every week since this spring and even now in September are bringing home tomatoes, eggplants, and Swiss Chard lettuce. What's more, our sweat and effort resulted in being awarded First Place Winner for First Year Garden by the University of Maryland Extension Master Gardeners in August.

Amazingly, it took only two months from the time of our first organizational meeting until our April ground breaking in Northwest Park to establish the garden this year. Without realizing what I was doing, I inadvertently organized the garden as a result of several fortunate factors. For starts, Mount Washington's list-serve was instrumental in connecting interested residents. In addition, Larry Kloze, a master gardener who has a history of creating vegetable gardens in Baltimore and is a long-time resident of Mount Washington, readily agreed to mentor the group. And finally, the Parks

Department approved the establishment of the garden in Northwest Park contingent on the Mount Washington
Improvement Association's approval, which we received in record time. We were unbelievably lucky as our timing also coincided with the creation of a master plan for the park, located on West Rogers and Wexford Road, that now includes the garden. Named in memory of Eric Waller, a Mount Washington resident and master gardener in his own right, the community

vegetable garden membership consists of 27 households. During our inaugural year we have been delighted at how well we work together, thrilled to know more of our neighbors, and amazed at how rewarding the work has been for adults and children alike.

We meet weekly on alternating Saturday and Sunday mornings for one hour, and harvesting and distribution are always done as a group. As a result of the garden's abundance, we have met our goal of also being able to donate crops to Our Daily Bread every week. In terms of the price tag, the annual household membership fee was \$70 this inaugural year, even with all our initial start up costs.

It is likely that we will be able to expand next spring. #### **SNAP**

The six year old Strategic Neighborhood Action Plan for Northwest
Baltimore is undergoing an update. The plan sets out spending and planning priorities for the Mt. Washington,
Cheswolde, Fallstaff, Glen and Cross
Country Neighborhods and is used by the
City Department of Planning in formulation of the City's Capital Improvements
Budget. For the next ten years, the SNAP plan will also guide the allocation of
"impact" funds received from the State's slots parlors that are granted to communities adjacent to racetracks.

In the first year of "slots money" availability, Mt. Washington representatives led an effort to allocate the funds to local schools, and to fund a comprehensive traffic and transportation study of the area aimed at finding ways to improve traffic flow, calm speeding and aid pedestrians. MWIA representatives are now meeting with leaders from the other community associations and the City Dept. of Planning to set out other long term goals in the areas of education,

housing, open space, streetscaping and public safety.

#### The Falls

Many Mount Washingtonians were stunned and saddened at the sudden closing of The Falls restaurant last month. The Falls was in business for about two years before folding and had become a popular lunch and dinner spot for many neighborhood locals and visitors alike.

Prior to becoming The Falls, the space at 1604 Kelly Avenue in the Village had been an A&P Food Store, a mini-mart and lunch counter and a delicatessen. MWIA has negotiated certain restrictions on the liquor license concerning use, hours of operation and signage to insure that businesses located there are a good fit for the community. The committee will closely monitor the transfer of this license to insure that any new business in this space is an asset to the community.




